PUBLIC PLEASURE GROUNDS

- **Apart from specific areas in parks designated as pet gardens, dogs are generally not allowed in public pleasure grounds**



PUBLIC PLEASURE GROUNDS

BACKGROUND

- LCSD has all along adopted a proactive approach to address the demand of dog owners.
- The number of pet gardens managed by LCSD has increased from 19 to 50 between 2010 and Aug 2019.
- After obtaining the support of the respective district councils and the local community, LCSD launched a trial scheme on Inclusive Parks for Pets in six selected parks in January 2019.

TRIAL SCHEME ON INCLUSIVE PARK FOR PETS

AIMS

- Enabling park users and members of the public who bring their pets into public parks to use park facilities together in an inclusive environment.

SELECTED VENUES

1. Victoria Peak Garden in Central and Western District
2. Kai Tak Runway Park in Kowloon City
3. Tong Yam Street Hillside Sitting-out Area in Sham Shui Po
4. Tai Wo Hau Road Playground in Kwai Tsing
5. Shing Mun River Promenade Garden No. 3 (Area B) in Sha Tin
6. Wang Yip Street South Rest Garden in Yuen Long

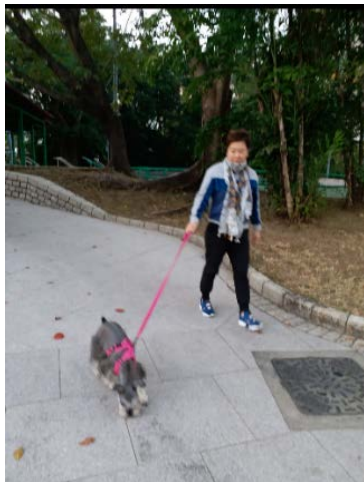

TRIAL SCHEME ON INCLUSIVE PARK FOR PETS

Users' Code

- Please keep your dog on a leash.
- Make sure your pet is kept under proper control and effectively restrained from causing nuisance or danger to other people and pets.
- Do not allow your pet to foul indiscriminately.
- Keep the environment clean and hygienic.

TRIAL SCHEME ON INCLUSIVE PARK FOR PETS

FACILITIES

- As the Inclusive Parks for Pets are not specifically designed for use by pets, the pet facilities provided there are less than those provided in pet gardens.
- Nonetheless, additional dog excreta collection bins have been provided and cleansing efforts have been stepped up by LCSD in the Inclusive Park for Pets.

- Consider whether to provide “Inclusive Park for Pets” in more districts

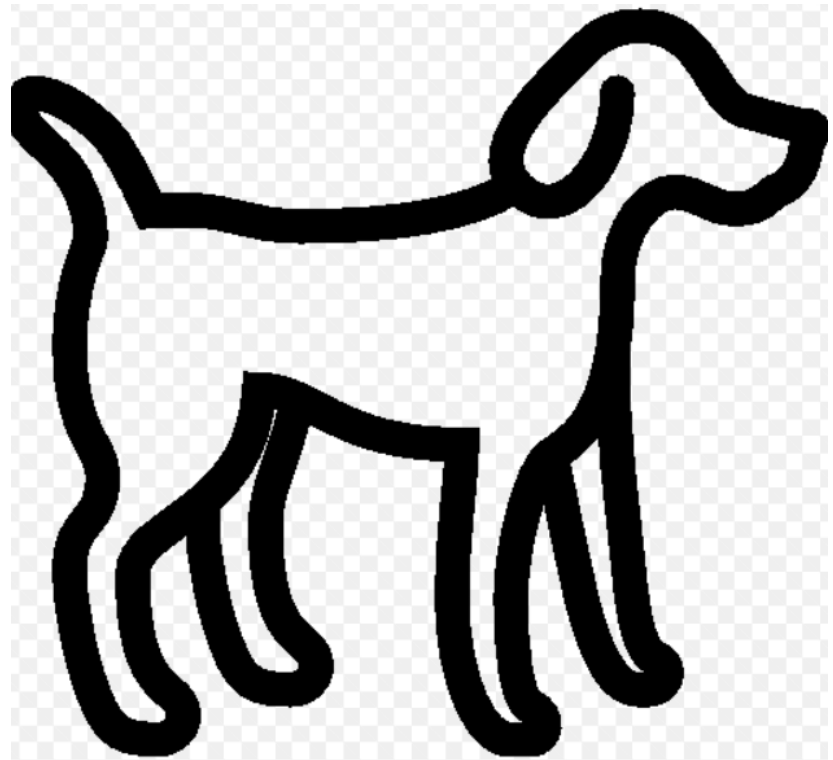
